WHO CAN APPLY?

The Agency applying to carry out Impact Assessment must fulfill the following conditions:

- i.) The Agency may be a Government Undertaking / Registered Company / Registered Consultancy Firm / Registered Non-Government Organization / Academic Institution, specializing in conducting Impact Assessment in the social sector.
- ii.) The Agency must have a minimum of three years' experience of carrying out Impact Assessment/
 Monitoring & Evaluation work in the domain of Corporate Social Responsibility/ Sustainability
 Services/ Community Development Projects financed by any Central Ministry/ World Bank/
 NABARD and/or other international donor institution (e.g., ADB, EU etc) or Central / State Public
 Sector Enterprise.
- iii.) Key Persons involved in the project should have post graduate qualification containing Social Research/research projects as part of the curriculum and must have experience of having conducted impact assessment for a minimum of three Projects.

PURPOSE OF ENGAGEMENT

FWWB intends to engage an external professional organization/individual to conduct an impact evaluation of various capacity building & catalytic funding programs under its flagship program on Women's Livelihood & Entrepreneurship Promotion

OBJECTIVES & SCOPE OF WORK

Objective

- The role of the agency will be to undertake comprehensive study of the project in consideration.
- To assess effectiveness of the service provision strategy and activities in achieving expected outputs, leading to outcomes
- To assess the qualitative and quantitative impact of the interventions in improving wellbeing among beneficiaries

Critical Areas of Evaluation

- The agency shall define for evaluation & impact assessment including conducting socioeconomic assessment
- Quantitative and qualitative program achievements.
- In consultation with program implementation teams, the agency will define a comprehensive methodology for evaluation and impact assessment.
- Document best practices, success stories and key highlights
- During the assessment the agency should map program contribution towards Sustainable Development Goals, Section VII and National Priorities.
- The methodology should also map achievement of program objectives, expected impacts in the long run, intangible benefits derived from completed projects

- Target Population: The target population will include the beneficiaries of the interventions, network of
 partner institutions, and other stakeholders. However, the sample selection criteria and sampling
 strategy would be developed in collaboration with FWWB
