Key Responsibilities

 - Liaise with ERP vendors to communicate requirements and troubleshoot issues
 - Ability to document requirements lucidly and manage knowledge transfer to vendor
 - Ability to oversee delivery as per timelines and participate in functional and non-functional testing of deliverables
 - Track procurement and use of licenses
- **AWS Cloud Operations**
 - Perform basic administrative tasks on AWS, including EC2 and RDS management
 - Monitor cloud resources and ensure uptime and cost-efficiency

- Oversee subscription and payment of invoices in a timely manner
- **Data Pipeline Oversight**
 - Operate and monitor data pipelines feeding into central storage and dashboarding tools
